

ACT OF THE SENATE

TO

ANNEX the Manor of Tricornia

Be it enacted by HIS IMPERIAL MAJESTY THE FAITHFUL PAVLOVIAN EMPEROR AND AUTOCRAT OF THE ROMANS AND ALL RUS', Defender of the Faith, Turtle and Elephants, in the Eighth year of His Imperium and in the first year of the consulate of Princeps Christophoros Sclagamarus filius Drakon and Comes Eduardus Robertus filius Gundersovus, in the year Seven thousand Five hundred and twenty eight after the creation of Adam, by and with the advice of all Senators, and by the authority of the same, as follows:

- I. Article V of the Basic Law of the Empire of Pavlov is amended to:
 - A. Pavlov is located on 52°23'12.2"N 4°37'31.5"E (Aleksandropol), on 52°23'35.6"N 4°56'21.5"E (Theodosia), on 52°23'37.1"N 4°56'30.7"E (Mariupol), on 48°09'34.8"N 17°05'40.3"E (Bratislava), on 41°00'11.4"N 29°01'51.2"E (Tsisarhorod') on 50°18'27.0"N 30°39'56.4"E (Osokorky), on 55°47'49.6"N 37°33'15.8"E (Moskva), on 65°44'02.6"S 63°21'01.2"W (Hrejmanna) and on 44°45'15.6"N 20°38'51.9"E (Triconia).
- II. Article XLI of the Basic Law of the Empire of Pavlov is amended to:
 - A. The Administrative divisions of the Empire shall be:
 - 1. Obolensk'a land
 - a) Uyezd of Novhorod-Zakhidskyj
 - (1) City of Aleksandropol (52°23′12.2″N 4°37′31.5″E)
 - (2) Town of Theodosia (52°23'35.6"N 4°56'21.5"E)
 - (3) Town of Mariupol (52°23'37.1"N 4°56'30.7"E)
 - 2. Velika Moravsk'a land
 - a) Uyezd of Moravia
 - (1) Town of Bratislava (48°09'34.8"N 17°05'40.3"E)
 - 3. Rims'ka land
 - a) Uyezd of Phrakija
 - (1) Town of Tsisarhorod' (41°00'11.4"N 29°01'51.2"E)
 - 4. Kyivs'ka land
 - a) Uyezd of Kyiv
 - (1) Town of Osokorky (50°18'27.0"N 30°39'56.4"E)

- b) Uyezd of Volodymyr-Suzdal
 - (1) Town of Moskva (55°47'49.6"N 37°33'15.8"E)
- 5. Antarktsk'a land
 - a) Uyezd of Hrejmanna
 - (1) Manor of Hrejmanna (65°44'02.6"S 63°21'01.2"W)
- 6. Velika Moesisk'a land
 - a) Uyezd of Verkhnjaja Moesija
 - (1) Manor of Triconia (44°45′15.6″N 20°38′51.9″E)
- III. Mykola Sladzhanovych Jovanov is created the Prince of Velika Moesija and Baron of Triconia the title being granted unto him and the heirs male of his body lawfully begotten and to be begotten.
- IV. In light of Article XLII § II of the Basic Law of the Empire of Pavlov, the official legal name of Mykola Sladzhanovych Jovanov is changed into Mykola Sladzhanovych Moesiskyj.
