ACT OF THE SENATE

TO

SAFEGUARD the physical and mental well-being of Pavlovians against unscientific propaganda and yellow press

WHEREAS the lethality of and mortality of COVID-19 has been shown to be consistent with influenza;

WHEREAS the risk of death for the healthy general population of school and working age is comparable to a daily car ride to work;

WHEREAS about 80% of all people infected with SARS-CoV-2 develop only mild symptoms or no symptoms, and about 95% develop at most moderate symptoms and don't require hospitalization;

WHEREAS up to 60% of all people may already have a partial T-cell immune response against the novel coronavirus;

WHEREAS the median age of death in most Western countries is over 80 years;

WHEREAS up to % of the extra deaths occurred in nursing homes and no conclusive evidence exists that these deaths resulted from COVID-19 and not from extreme stress and isolation;

WHEREAS the lockdowns led to a massive decrease in the treatment of heart attacks and strokes;

WHEREAS in most countries, the ratio of positive tests stayed below 20% no matter the "exponential curves" which coincided with an exponential increase in testing;

WHEREAS countries without a lockdown, such as Japan or Sweden, have not experienced a more negative course of events than many other countries and evidence exists that Sweden now benefits from higher immunity compared to lockdown countries;

WHEREAS little to no scientific evidence exists for the effectiveness of face masks and no evidence exists that the introduction of mandatory masks influenced the contagion rate;

WHEREAS virus tests have been shown to produce false positive and false negative results, react to non-infectious virus fragments or react to other common coronaviruses;

WHEREAS several medical experts have described coronavirus vaccines as unnecessary or dangerous, the vaccine against so-called “swine flu” led to cases of severe neurological damage and serious complications have already been reported in the course of testing novel coronavirus vaccines;

WHEREAS the number of people suffering from unemployment, depression, and domestic violence as a result of the containment measures has reached an all-time high and may claim, according to experts, more lives than the virus itself;

WHEREAS the mainstream media has been repeatedly caught trying to dramatize the situation in hospitals and using manipulative images;

WHEREAS the implementation of restrictive measures constitutes an attack on religion and restricts the right of worshippers to partake in religious activities;

WHEREAS this Holy Empire has consistently stood as a bastion of logic, rational thinking, and Christian values against far-left propaganda; and

WHEREAS it is in this Holy Empire’s interests to protect her subjects against unscientific propaganda and yellow press seeking to destroy the established world order and drive humanity into poverty, depression, and anxiousness –

Be it enacted by HIS IMPERIAL MAJESTY THE FAITHFUL PAVLOVIAN EMPEROR AND AUTOCRAT OF THE ROMANS AND ALL RUS’, Defender of the Faith, Turtle and Elephants, in the Eighth year of His Imperium and in the first year of the consulate of Duchissa Helena Alexandra filia Kirsanova and Comes Eduardus Robertus filius Gundersovus, in the year Seven thousand Five hundred and twenty nine after the creation of Adam, by and with the advice of all Senators, and by the authority of the same, as follows:

- I. The so-called “coronavirus pandemic”, also known as “COVID-19 pandemic”, is hereby declared a hoax.
- II. A Pavlovian subject found guilty of
 - A. spreading fake rumours about the existence of a “coronavirus pandemic”
 - B. wearing face masks without displaying symptoms of a disease, or encouraging others to do so
